# **ARS 100 Introduction to Art**

## 1. ONLINE COURSE EXPECTATIONS

## 1.A. STATEMENT OF ACADEMIC RIGOR

- Online courses are just as rigorous as 16-week, in-person courses, so expect your coursework to be challenging but rewarding


Remember all questions related to hardware, software, browsers, and the Canvas Learning Management System are outside the instructor's expertise.

#### 3. COURSE OVERVIEW

ARS 100 is designed for non-art majors to help understand and appreciate the relevance of art. The course combines discussions of the language and elements of art with opportunities for critical thinking. The course will provide an introduction to the understanding and enjoyment of art through the study of artistic media such as painting, sculpture, architecture, design, photography and the decorative arts. Contemporary topics and cultural diversity in the arts are a special area of emphasis. Over the duration of the course students will develop familiarity with a variety of artistic media and techniques and learn art-related terminology. These lessons will help students learn how to articulate what they perceive in an artwork and increase their understanding of how art's visual components affect them and other viewers.

## 3.A. STUDENT LEARNING OUTCOMES | COURSE OBJECTIVES

- 1. To understand the motivations behind and significance of art in human society
- 2. To learn the basic elements and principles of design in the visual arts and to learn major categories of 2-dimensional / 3-dimensional media
- 3. To recognize stylistic, thematic, and influential relationships among artworks
- 4. To reach a level of dynamic engagement with art objects, viewing them as expressions of a particular cultural moment
- 5. To increase your ability to reflect on the basis of our own art judgments

# Students must earn a <u>perfect score</u> on the syllabus quiz before they are permitted to advance in the course.

- The course begins with a "Getting Started" module followed by four (4) instructional content modules or units
- The syllabus quiz is located at the end of the "Getting Started" module
- Students will have access to the "Getting Started" module and syllabus quiz as soon as the course begins
- The syllabus quiz has 20 multiple-choice questions, each worth 1 point
- Students have 10 minutes to complete the guiz
- Students have multiple attempts to earn a **perfect score**, but they must observe the final deadline for full credit
- For each 24- hour period past the deadline, one penalty point will be deducted from the for late submission of the syllabus quiz

## 3.E. STUDY AIDS

**STUDY GUIDES** are provided by the instructor for each module to help you focus your notes.

- TIP: Keep the module study guide at hand while you read and listen to video lectures and use them to take notes
- That way you can summarize the right information and spend more time preparing for the tests

**CENGAGE'S MINDTAP** also has its own chapter study guides as well as customizable vocabulary and image flashcards. To help you determine your test-readiness, MindTap also has a Foundation Interactive practice quiz for each chapter. If you know the definitions and the information on the module study guides AND have utilized MindTap study aids, you should do well on the tests----unless you procrastinated and tried to cram at the last minute.

## 3.F. REQUIRED READINGS & VIDEO LECTURES

To be successful you will need to complete all assigned readings and video lectures. Don't underestimate the challenge that a course on art poses.

- Readings and video lectures are located in the content module folders
- The readings for various lecture topics are listed on our Canvas course website.
- Independent art historian Eileen Engle is the "voice" of the video lectures
- Video lectures last between 10 15 minutes each and lectures on a topic may be broken into separate segments
- Video lectures can be repeated or paused at any time so you may take notes.
- TIP: The video lectures will make more sense if you have done the assigned reading first.

## **3.G. END-OF-SEMESTER DISCUSSION ASSIGNMENT**

NO make-ups for this assignment are permitted (due to the semester schedule and the amount of time the assignment is available to students)

- The discussion question is worth 10 points
- There are no right or wrong answers, but be mindful of mechanics and tone (how you sound)
- For FULL CREDIT you must contribute a thoughtful response, practice professionalism, and demonstrate university-level communication skills

## 3.H. END OF SEMESTER EXTRA-CREDIT OPPORTUNITY

NO make-ups for this assignment are permitted (due to the semester schedule and the amount of time the assignment is available to students). There is one and only one opportunity for extra credit available. This assignment will help boost your grade- and it cannot hurt your grade, so be sure to do it!

- The extra credit is worth 20/0 points, despite what the Canvas gradebook says
- Your computer must be capable of playing an hour-long movie file
- You may use a computer on campus if your personal computer is not capable of playing movie files
- If you encounter technical difficulties contact the ASU Help Center right away. Any technical issues must be resolved before the extra-credit opportunity closes
- To earn the twenty (20) points, you will first watch a video, then you have 20 minutes to provide correct answers to five (5) multiple-choice questions
- Each correct answer is worth 4 points.
- While listening to the video, keep track of the sequence of how stories were developed as well as other pertinent information. Know the names of the different stories as well as other pertinent information.

#### 3.I. TEST FORMAT

- Each module quiz and exam have questions that are drawn from the material in that module (lectures, their associated readings, and study guide).
- Tests are not cumulative
- Tests are comprised of multiple-choice questions
- There are multiple versions of each exam, so students will receive a different version of the test
- Each instructional content module contains a 10-question guiz and a 40-question exam
- Students have 10 minutes to complete quizzes and 35 minutes to complete exams
- All tests are open note, but they must be <u>your own notes</u> compiled by working your way through the course lectures and readings. See section 2.A. for what constitutes cheating in this course.
- DO NOT SUBMIT a test if you encounter technical issues while the test is open. Log out and contact ASU's 24/7 Technical Support

## 3.K. TEST SCHEDULE & COUNDOWN TIMER

The schedule is published in Canvas and includes upcoming due dates. Students are responsible for keeping track of all course deadlines. Note that Canvas posts when a test **CLOSES**, not when it opens!

- Deadlines are NOT flexible, unless a student has accommodations through the Disability Resources Center.

## **3.L. EXCEPTIONS TO NO MAKE UP POLICY**

Given the seven (7) day window to complete a quiz or exam, make ups are granted only under exceptional circumstances and when a student meets the following conditions:

- Within 4 days of your unscheduled absence, you provide documentation that verifies you were <u>incapacitated during the period</u> the test or assignment was open to you
- Your formal documentation clearly states your name, the dates you were incapacitated, and the reason for your incapacitation. Those dates must coincide with the seven (7) day window the test or assignment was open to you
- Students registered with the DRC whose accommodations include flexible deadlines
  have 24-48 hours to contact the instructor about a missed deadline. Failure to do so
