Course Description

In this upper-level undergraduate/graduate course exploring the African American rhetorical tradition, students will survey the ways African Americans have used various modes of communication and persuasion to construct and reconstruct images of themselves, and to advocate around issues of racial justice and equality. Course readings will consist of both primary texts and criticism, and will include: studies in black language by Geneva Smitherman, Sammy Alim, Elaine Richardson, and Ronald Jackson; the abolitionist rhetoric of David Walker and Frederick Douglass; explorations of the rhetoric of 19th century black women such as Maria Stewart, Ida B. Wells, and Anna Julia Cooper; the rhetoric of civil and human rights as articulated by Fannie Lou Hamer, Ella Baker, Martin Luther King Jr., Malcolm X, and activists of the Movement for Black Lives; and the rhetoric of former President Barack Obama and former First Lady Michelle Obama as they negotiate the precarity of blackness within the historically white space of the U.S. White House and Oval Office.

<u>Course Objectives</u>: Upon successful completion of this course, students will be able to:

- Define rhetoric in their own terms
- Identify and interpret a wide variety of African American rhetorical practices
- Identity the relationship between rhetoric and ideology
- Identify the rhetorical signatures of movements for racial justice and equality
- Produce substantive written analyses of African American rhetorical practices
- Articulate and develop a lengthy scholarly essay that explores an aspect of African American rhetoric (specific to graduate students in this course)

Course Format & Expectations

This course is designed as a survey course in the African American Rhetorical Tradition. We will read a combination of primary and secondary texts with attention to how African Americans use language and action to rhetorical ends. This course will operate as a proseminar, which means our focus will be more on reading and discussing texts than producing lengthy analyses. As a result, this course will run as an ongoing conversation in which texts are closely examined, analyses are rendered and reevaluated, and more refined insights and understandings are reached. Course assignments will focus on helping seminar participants synthesize information and map the tradition for future research and study. Seminar participants are expected to attend class with texts read, annotated, and accompanied with a series of insights and/or questions intended to move conversation forward.

Course Assignments

The assignments for this course are designed to deepen your understanding of rhetoric, to help you identify and map the African American rhetorical tradition from the 18th-21st century, and to provide you with a foundational base from which to produce future research.

1. Reading Responses (20%)*

Seminar participants are responsible for submitting a Reading Response (RR) each week. RRs should be 1 page in length, single spaced, 1-inch margins, and should engage the assigned readings in a thoughtful and thought-provoking manner. RRs are not reading reports, that is, they are not 1pg descriptions of what you read. Rather RRs are investigative reflections that critically engage course readings. Ideally, these papers will provide explorative space in which to parse out themes and ideas that will culminate in your final project. RRs are to be submitted as word attachments via Canvas by 11:30pm the Tuesday night before Wednesday's class. This means that you will always submit a RR the night before class. Items not submitted to Canvas by the deadline will not be accepted.

2. <u>Discussion Leads (15%)*</u>

Each seminar member will be responsible for leading discussion on a selected week. Discussion leads should consist of a ten to fifteen-minute synopsis of the material read and should conclude with 2-4 questions intended to generate class discussion. All course participants are required to meet with me before their scheduled discussion lead. Discussion leaders will be exempt from the week's reading response.

3. Annotated Bibliography (15%)*

Seminar Papers/Literature Reviews must be preceded by an annotated bibliography consisting of 10-12 sources. Annotations are to be no longer than 300-400 words in length and should consist of the following: a brief summary of the assigned text, an explanation of its central argument, an explanation of how it relates to other studies of African American rhetoric, and an explanation of how it contributes to your understanding of

rhetoric.

4. Short Paper/Seminar Paper (30%)*

Short Paper (Undergraduate Students)

Undergraduates in this course will produce a short 8-10pp paper that describes, summarizes, and critically evaluates a topic/issue on African American rhetoric of interest to them. As with reading responses, I will be looking for a clear articulation of argument, integration of evidence, and strong organization.

Seminar Paper (Graduate Students)

Graduate students in this course will produce a seminar paper that should take the form of a scholarly article or dissertation chapter. This paper should make an extended argument engaging a topic of interest as it relates to African American rhetoric. As with reading responses, I will be looking for a clear articulation of argument, integration of evidence, and strong organization.
