Course Description:

PAF 503 is designed to examine the conceptual and contextual framework of public administration. It deals with the evolution, meaning, significance, and content of public administration both as a profession and as a field of study. Topics covered in the course include: theory and development of public administration, bureaucracy in the public sector, public policy making, leadership and management in public organizations, inter-governmental relations, public finance, and public administration reform. The course is meant to lay a solid theoretical foundation for students who seek to pursue a career in public service or public administration research.

Assignments and Grading:

Weekly Classlog for Reading Notes (40%) (Classlogs are submitted every three weeks and the final merged version shall be submitted towards the end of semester): Timely accomplishment of the required readings is essential for students to appreciate the substance of the issues covered in the course, and to benefit from class discussions. Reading notes should be taken carefully, organized using navigation pane in word (or other similar function if you are using a different work processor). Please use the Classlog Template file for reading guidance. It gives your specific instructions on what to read and what to record. You could enrich the content of the Classlog by adding more subtitles but should not ignore the required items in the template.

Book Report (30%): Besides the required readings, each student is asked to select and read one book from the provided reading list and write a book report on it (If you want to select another book of relevance on your own, it is also acceptable. Remember, the book should be relevant to Public Administration and Policy). The report should include the following parts with subtitles (also highlighted in the navigation pane): full citation of the book, the gist or highlights of the book, the implications of the ideas in the book for contemporary public administration, what other authors or commentators said about the book, and your own comments and evaluation of the book. The book report should be no less than 3 pages and no

more than 10 pages long, doubled spaced, using navigation pane, and with full references.

Final Examination or Term Paper (30%) (You could choose to write answers to final examination or write a term paper. Final questions shall be posted one week before the final date). Final examination is an open book examination including definition of terms, short answers to questions, and short essays.

The research paper should include at least five parts: I. Introduction of the research question. II. Relevant literature and theories. III. Data analysis, cases, anecdotes, and findings. IV. Discussions of the findings. V. Your conclusive comments. Full citation information should be included in the paper using APA style (American Psychological Association Style. Information on how to use the reference style is easily available through the internet). A minimum of five references should be used (ideally 20 or more). The topics of the paper could be: How Public Administration Has Contributed to America's Rise; The Highlights of Intellectual American Public Administration; Great Leaders in American Public Affairs; Important Public Administration Theories (Discuss at least 5 authors); American Public Administration: Past, Present, and Future Prospects; American PA in Today's Globalized World; American PA in Today's High Tech World; American PA in an Urbanized World, How Could America Better Fight COVID-19? The Proper Role of Government in COVID-19 Pandemic Control. The Paper should be no less than 12 pages long double spaced with full references. Term paper is due towards the end of the semester (See Canvas Modules).
