Course Description

ABS 360 is a multimedia *i*course for surveying contemporary topics about home gardening in the Southwest, including landscape design and installation, flower and vegetable gardening, citriculture, interiorscaping, and others.

Course Objectives

This course is aimed to:

- 1. Develop an interest in home gardening
- 2. Demonstrate successful practices for home gardening
- 3. Introduce a variety of plants that grow well in the Southwest
- 4. Provide reliable resources for further information

Course Learning Outcomes

After completion of this course, students will be able to:

- 1. Define basic terminology used in horticulture
- 2. Describe the basic characteristics of landscape plants commonly used in the Southwest
- 3. Identify the key features of desert soils and the use of soil amendments
- 4. Outline the features of effective and sustainable landscape and vegetable garden design and maintenance, including plant and site selection, irrigation, pruning, tools, pest control and composting practices
- 5. Describe the essential practices in turf establishment and maintenance
- 6. Identify the essential elements in citrus and date production.

Course Format

ABS 360 is an A session (8/19/21 to 10/8/21) *i*Course on MyASU Canvas that consists of four content modules. Each module consists of three topics about different aspects of home gardening in the Southwest including how to design and maintain sustainable landscape gardens, gardening for home landscape amenity, and gardening for food.

This course is organized so that students can sequentially complete all the activities and quizzes for each module at their own pace, provided they do so prior to the module deadlines given below. All students must first perfectly complete a 10-point quiz to show their full understanding of the course syllabus, format, policies and deadlines, and instructor expectations for student success prior to accessing the content modules. Students are allowed multiple attempts to perfectly complete this 10-point quiz.

For each module, students must review all information including readings, videos and then complete three online quizzes before the module deadlines given below. Prior to taking the online quizzes, students should print out the topic study guide, complete the short reading assignments, view the instructional videos, and finally fill out the study guide. Having completed this, students will then be prepared to successfully take the online quizzes. The module quizzes are open notes and can <u>only</u> be taken once prior to the module deadline. There will be no opportunities for students to complete quizzes within a module after the module deadline. Announcements will be posted for students on the Canvas Web page to remind students of upcoming module deadlines. These Canvas announcements are merely reminders given to students as a courtesy. Students failures to read these courtesy reminders does not constitute an excusable reason for failure to perform.

Required Textbook

There is no required textbook in this course. Students wanting more subject information should purchase The NEW Sunset Western Garden Book, 2012 Edition. Students may purchase this text at many local bookstores and garden centers. It is also available online at amazon.com. This is a general book about landscaping and gardening in the western United States. This textbook is a great resource with information that students will find useful for the course, as well as information about plants adapted to the desert Southwest. Otherwise, there are reading assignments posted on Canvas.

Students are allowed to work through the course materials at their own pace with the following caveats:

- 1. Students must review all content material and submit the quizzes for each topic within a module prior to the module deadline before moving on to the next module in the course.
- 2. Quizzes within a module that are not completed prior to the module deadlines published above will be given an automatic score of 0.

- 3. Quizzes must be submitted to unlock the next topic, even after the deadlines.
- 4. Each topic's guiz is open book/notes and can only be taken only once.

The Course Grading System

Student's grades for the quizzes will be posted electronically in the MyASU Canvas gradebook. Final course grades will be issued by the course instructor on MyASU roster grades at the end of the session. A student's final course grade will be based on a 310 point system. Students will earn points on the 12 online quizzes. Plus and minus grades will not be assigned. There are no extra credit opportunities for students in this iCourse.

Course Policies

- There are no Barrett Student Honors contracts offered for this course.
- Students are strongly encouraged to not procrastinate by waiting until the last few days
 before a module deadline to review the module content and do the module
 assessments. Students should be in the habit of monitoring their grades, especially after
 the closing of a module deadline. If students feel there is a discrepancy, contact the
 course instructor ASAP. **DO NOT** wait until the end of the semester to check grades
 and ask to make up work. This request **WILL BE** denied.
- The module deadlines are fixed and NO extensions will be granted to students after 5 days before each of the module deadlines posted above. For example, the first module deadline is September 15, which means that after September 10 NO extensions will be granted regardless of conditions or circumstances.
- Student requests for an extension to a module deadline are not guaranteed. The course
 instructor reserves the sole right to grant or deny a student's request for a module
 extension. Under the unusual and rare situation or circumstance in which the course
 instructor does grant a deadline extension, the extension interval given to students is
 generally only 1 to 2 days.
- Students are strongly encouraged to take the course's online quizzes from a computer
 with a hard-wired Internet connection. Students are strongly discouraged from taking
 their online quizzes using a Wi-Fi or cellular phone Internet connection. When a student
 experiences any problems with Internet connectivity while taking an online exam, then
 the student will assume total responsibility for this problem and cannot use this problem
 as an excuse for non-performance.
- Students must keep in mind that the course instructor though always prioritizing student success, may not be able to resolve "last minute" kinds of Internet or Canvas related problems because of the very high number of students enrolled in this course. Students

must be mindful that in no way can the course instructor be held responsible or be expected to solve these types of student problems or issues.

Course Attendance Policy

This self-paced (asynchronous) *i*Course is delivered entirely online and there are no scheduled meeting times with the instructor. Attendance in this course is indicated by engagement with the course on a regular basis. Students are expected to log into Canvas course site regularly, follow any directions given through announcements or emails, review the assigned materials, and submit all assignments before the deadlines indicated in the course schedule.

Missed Assignments/Quizzes Due to University-Sanctioned Activities and Religious Holidays

Since this is a self-paced online course and ample time is provided for completion of graded activities, there will not be any makeup opportunities for missed assignments or quizzes even when the due dates fall within or on times of university-sanctioned activities or ASU-recognized religious holidays. Course Time Commitment

Coursework includes all learning activities including reading, watching videos, studying, and completing assignments. Arizona Board of Regents (ABOR) requires 45 hours of coursework per credit for college-level courses, which translates to:

3 credit hours = 135 total hours

4 credit hours = 180 total hours

Drop and Add Dates/Withdrawals

If you are unable to take this course for any reason, be aware that there is a limited timeline to drop or add the course.
