INTRODUCTION TO CLINICAL HEALTH CARE BIO/MED/HON/ABS 494 – Syllabus – Fall 2021

Course Description

The course offers interactive lectures with leading healthcare providers, small group case-based instruction, and digital medical procedural demonstrations and simulations designed to provide students with exposure to the practical applications in healthcare. Intended for students seeking a career pathway in pre-health professions.

Learning Objectives

- Understanding the basic skills involved in clinical examinations and be able to discuss how they are applied in individual medical disciplines.
- Appreciate the many personal pathways individuals take to prepare for career in healthcare.
- Recognize how members of healthcare team contribute experiences, skill sets, and resources that lead to better overall health outcomes for patients
- Recognize health disparities challenging Arizona and be able to discuss strategies healthcare providers are using to solve them.
- Improve communication skills, including writing, verbal responses, and presentation development and delivery.
- Understand and employ strategies for successful application to health professional schools

Course Activities

Clinical Examination Skills

Students will be provided with a combination of lectures, readings, videos, and simulations to develop a foundational understanding of the complete subjective health assessment in the context of health and illness. Students have the opportunity to learn how to respond to normal, abnormal, and critical findings when completing a complete subjective health assessment of patients across several medical disciplines.

Meet with Health Care Providers

Students will get the opportunity to meet with and learn from health care providers from multiple medical disciplines. The speakers will represent a diverse set of health professions in order to stress the importance of Teamwork in health care and the multitude of career paths the students may consider. There will also be an emphasis on the health disparities challenging our community and efforts to solve them.

Application Preparation

Students have the opportunity to meet with Pre-Health Advisors, Admissions Committee Members and current students to gain insight on how to be competitive when applying to health professional schools.

Students will be required to read one of the books from the suggested reading list and complete a writing assignment with prompts.

Assessments

Course assessment will be based on the submission of short reflections and an end of the semester report on one of the assigned books.

- **A. Reflective writing:** All reflective writings are due two weeks after the event. You will be required to write 400 to 500+ word reflections using the provided prompts on:
- 1. assigned surgical videos,
- 2. assigned articles, and

- 3. chosen Mayo Clinic continuous medical education modules,
- **B.** Independent Reading: You will be required to read one of the recommended reading and submit and 1000 to 3000 word essay using the provided prompts. The essay is due by the last day of the semester.

Grading Policy

Grading will be Pass/Fail only. Passing this course requires:

- 1. Completion of at least 80% of the assignments,
- 2. Cumulative percentage grade of 75% (C) or better,
- 3. Attending 90% of the scheduled sessions (0-5 missed sessions), and
- 4. Completing the independent reading assignment.

Absences and Participation Points

This course is designed as a highly interactive course and students are expected to be active participants.

Your attendance in lectures counts as part of your participation grade. Students must attend 90% of live lectures to pass the course. We understand there may be technical difficulties. Lectures with guest speakers will be taped and made available.
