Introduction to the historical, social, political, economic and interprofessional contexts in which healthcare professions and the United States healthcare system evolved.

General Course Overview/Objectives

This course provides a broad introduction to the evolution of healthcare, the healthcare system of the United States, and healthcare professions. Learners will identify key historic and current factor related to the structure of healthcare organizations, payment methods, pivotal legislation, ethics, and the development of interprofessional healthcare and education.
