Syllabus for HCD330: Health Care Systems in the U.S.

Fall, Session B, 2022

Course Description: Introduction to health care systems in the United States with an emphasis on the social determinants of health and the professional, organizational, community, and financial resources necessary for the delivery of health services.

Course Overview:

The focus of this course is on the history of the U.S. healthcare system that includes financing, insurance, delivery of services, and payment. A description of how the different components interact with one another that enable individuals to receive health care, and how health care services are provided, will be examined. Specific issues such as quality of care, access to care, managed care, private and public delivery systems, and health disparities will be addressed.

Learning Outcomes:

Upon completion of this course the student will be able to:

- 1. Explain the historical development and transformation of health care delivery in the U.S.
- 2. Describe the various modes of service delivery: inpatient, outpatient, long-term care
- 3. Compare and contrast the roles of different types of health care providers.
- 4. Describe the key differences between public and private models of health care delivery.
- 5. Discuss the role of health care financing and its impact on the delivery of healthcare.
- 6. Describe the social determinants of health.
- 7. Describe the needs of special populations, health disparities, and access to care.
- 8. Explain outcomes in terms of quality of care and consider directions for the future.

Methods of Instruction:

Online participation is a necessary part of the online learning experience. Failure to participate can result in a recommendation for withdrawal from the course. This course uses *Canvas* to provide course documents and information, to facilitate communications between faculty and students, for submission of assignments, and for posting grades. Rubrics:

Rubrics provide students with explicit descriptions of assignment grading criteria. Students should use rubrics to clarify the expectations for an assignment. When used correctly, rubrics provide a fair assessment tool for students and instructors. Rubric criteria reflect the weighted importance of the assignment components. For example, if using AMA format was an important assignment

expectation, the instructor would communicate the significance by including AMA formatting as a criterion and weighting it appropriately. Rubrics also ensure that grading standards remain consistent over time, with the least amount of subjectivity. Moreover, rubrics help instructors understand the strengths and weaknesses of assignments; this usually leads to instructional improvement. Because assignments graded with rubrics are usually scored and returned, they also help instructors hone in on students' strengths and weaknesses to help them target specific areas where feedback may help students improve their learning. *Rubrics for assignments in the course and detailed instructions can be found in the Assignment Information tab for the course.*
