Communication 308 is an introduction to the many kinds of methods and research in Communication Studies. We will explore how different ways of knowing lead to different criteria for knowledge about human communication. The course covers quantitative, qualitative, and critical approaches. It is important to note that this course cannot cover any method of inquiry completely. Each is given more in-depth coverage in specialized 300-400 level courses.

#### **OBJECTIVES**

Upon completion of this course, the student should be able to

- 1. understand the scope of the discipline of communication.
- 2. understand the basic process of conducting research in communication.
- 3. evaluate the appropriateness of various research methods in response to research questions.
- 4. apply the appropriate style for writing research reports (APA).
- 5. write a coherent proposal to apply a method to a chosen topic.

## **COURSE PHILOSOPHY**

Here is what you can expect of me.

- 1. **RESPECT FOR IDEAS.** The instructor has a duty to make students think critically about their beliefs so that they can make choices in the world and defend them. This activity should always be respectful of those beliefs while testing their limits.
- 2. **PROFESSIONALISM.** The instructor should always behave professionally. This means being prepared for lectures, sticking to the syllabus, responding to phone calls or emails in a timely manner, and keeping office hours.
- **3. OPEN COMMUNICATION.** Students should be able to voice any concerns about theclass without fear of reprisal.
- **4. JUSTICE.** The instructor should grade papers and exams strictly on their merits. Students should never have to fear arbitrary or capricious grading.

Here is what is expected of **you**.

- 1. **BE AN ACTIVE LEARNER.** What you get out of this course depends on how much you put in. A good start is to have the assigned readings done prior to class discussion. You are then able to engage in classroom rhetoric. Speak up,ask questions, and contribute to the class.
- 2. **BE RESPONSIBLE**. Communication is inherently controversial due to its close ties to politics, relationships, culture, religion, and ethics. A responsible communicator will give respect to varied points of view. For the same reasons, some course content may be deemed offensive by some students. I try to provide warnings when introducing potentially distressing material, but if I miss something, please contact me. If you have any problems with the course, talk to me about them. I am willing to spend time with you to answer questions, discuss complaints, etc. We can schedule an office visit downtown, have a Zoom meeting, or even use email.
- 3. **BE ETHICAL.** Don't cheat or plagiarize. This means that when you write a paper you must cite the source of anything that is not your original work. This not only means direct quotations, but anything you paraphrase, or any ideas you borrow. Cheating or plagiarizing in any form is grounds for failing the course and may lead to formal university action. The formal college policy is included on the syllabus below.
- 4. **ALLOW YOURSELF TIME.** Work always piles up faster than you think. Do not try to do all the readings the night before an exam: concepts build on one another and must be learned thoroughly. For the research paper, give yourself time to proofread and edit. Acceptance of late papers is contingent upon the reason you did not complete the work. If accepted, 10 percent is deducted for each 24 hours late.

As college students you should write on a college level. This also takes rewriting. Spelling and grammar count. All papers must be typed in correct APA format.

## **ACADEMIC INTEGRITY**

It's simple. If you are discovered plagiarizing (global, patchwork, self or otherwise), there will be consequences. ## **Overview of Written Assignments**

#### **COM 308 Topic Proposal**

Your first written assignment is to choose a topic for your research journey and justify your choice. Be sure it is related to **communication**. Choose carefully -- the topic you select will be yours for the semester, although if you decide to change later in the class, we can discuss it.

#### Writing the paper

<u>Present a clear thesis statement. It should have to do with why you think this would be a good topic</u>. A thesis statement is always a single declarative sentence.

Your paper should also answer these three questions:

# 1. What Am I Doing?

Assume your reader does not know anything about your topic. Given how many topics are out there, this is a good assumption. Introduce us to it. One paragraph

is enough.

## 2. Why should we care?

Prove your case is significant. A topic can be significant in one or more ways. It could be a problem that many have noted but no one can solve. It may be something that will give us insight into how communication works. It may fill a gap in the research that already exists. Read some of the articles for class and notice how everyone "sells" their topic first thing. One or two paragraphs, depending upon how hard you think it will be to interest the reader.

## 3. What has already been done?

Provide five scholarly sources, as proof that the topic is researchable. Briefly explain why youchose them. You don't need to review these articles (yet), simply explain them enough to show that research exists for this topic. If you cannot find at least five good sources, reconsider your topic

## **Technical Requirements**

- 1. Length 2-3 pages. If you must go a *little* over, that's ok.
- 2. Proper APA format. No abstract is necessary.
- 3. At least **five scholarly** sources. More is fine, less is not. Scholarly means no newspapers, no magazines, and no blogs. Web sites are not allowed at this stage. Wikipedia is for high school. Non- scholarly sources are fine as **extras**.
- 4. File saved as an Adobe .pdf document.
- 5. Grammar and spelling count.
- 6. The paper must be turned in on Canvas by midnight on the due date.

# **Com 308 Article Analysis**

There are three major research paradigms. For these papers you will explore one published article from each paradigm. **The paradigm to write upon will be specified in the assignment.** These are worth 5% each. The article should be related to your topic. It does not have to be an exact match. Your task is to discuss the article as if you were evaluating it for use in your research project.

## Each paper will include at least two sources:

- 1. your textbook/class notes and
- 2. the scholarly article you are examining. Your task is to discuss your topic as if you were proposing a research project.

Then complete these tasks.

- First, remind the reader of your topic.
- Second. discuss
  - what specific method used is by the article,
  - how it fits within the paradigm
  - why it is a good fit for your topic.
- Third, evaluate any one conclusion the authors make following the claim, data, warrant structure of the Toulmin Model.
- **Finally**, based upon this article, pose a possible research question on yourtopic.

## Guide for choosing Articles for Analysis

#### Things to look for:

- Studies in communication journals
- Full studies that have analyses of data
- Studies that have identifiable methods

#### Do Not Use:

- Meta-analyses
- Literature Reviews
- Theoretical pieces
- Conference papers
- Dissertations
- Book chapters

# **Technical Requirements**

- 1. Length 3-4 pages. If you must go a little over, that's ok.
- 2. Proper APA format. (No APA, no A.)
- 3. The scholarly research article must be from the paradigm you claim.
- 4. File saved as an Adobe .pdf document.
- 5. Grammar and spelling count.
- 6. The papers must be turned in on Canvas by midnight on the due date.

#### **COM 308 Annotated Bibliography**

Review 10 scholarly articles related to your topic. To author your annotations, write between 100-150 words about each of the articles, focusing on **what** they found and **how** they found it. Pay close attention to method! After all, this is a methods class! What specific methods did the author use? Why? Finally, do **not** simply copy the abstract for each article. Doing so would constitute plagiarism.

Every essay will be a bit different, depending upon your final selections. But overall, these are your tasks.

#### **General Outline:**

- **1. What am I doing now?** Remind the reader of your topic. This is especially important, asyou will have narrowed/refined/altered it by now. If you still have exactly what you started with, you are doing something wrong. One short paragraph will do.
- 2. What approaches have others taken to the topic? That's your Bibliography! A list properly alphabetized and formatted in APA.
- **3. Given the literature, pose a Research Question of your own.** Now you must decide specifically what you want to find out! To defend this, briefly summarize

differences and commonalities in your reading. You may pose either a Research Question or Hypothesis, but keep in mind that the latter is more difficult to defend. The length of this section depends upon your argument, but don't go beyond a basic comparison.

#### **Technical Requirements**

- 1. The articles must be research studies published in peer reviewed journals.
- 2. At least **six** of the articles must be from Communication journals. The others can be from any discipline.
- 3. Proper APA format. This is a bibliography, after all. (No APA, no B)
- 4. File saved as an Adobe .pdf document.
- 5. Grammar and spelling count.
- 6. The paper must be turned in on Canvas by midnight on the due date.

# COM 308 COM 308 Application Paper

In this final paper think about how the methods that you have learned in class can be used in practical situations. How might you utilize the methods from this class?

Each of you has selected a topic that attracted your interest. Think about why you chose it. How might knowledge of this area be useful to you?

To structure the paper, offer a hypothetical (or actual) workplace, relational, social, or family situation or a communication problem that would need resolution. Then choose a method, propose how you would use it and how your research can assist in finding ways to resolve the problem.

#### **Basic Outline:**

#### 1. Introduction

a. Broadly speaking, discuss how communication methods provide practical possibilities in addition to research possibilities.

#### 2. Body

- a. Hypothetical scenario: Paint a picture of a workplace/family/social/relational problem or other moment when communication research might be useful.
- b. Choose a method: Describe the method and justify using it. In other words, why this method?
- c. Apply the method! Consider, depending on the approach:
  - i. Sample survey/interview questions
  - ii. Types of observations
  - iii. Types of texts

## 3. Conclusion

- a. Summarize your goals
- b. Bring it back to the beginning -- regarding practical application of methods.

Since the content of these will differ according to the chosen method, this is only a bare skeleton. There will be a guide posted on Canvas going over what needs to be included for each methodology.

## **Technical Requirements**

- 1. Length 8-10 pages. If you must go a *little* over, that's ok.
- 2. At least 10 sources. Make use of course materials and at least 8 of the sources from your annotated bibliography. You are allowed to add new articles.
- 3. At least 6 articles must be from Communication journals.
- 4. Proper APA format. No abstract is necessary. (No APA, no B)
- 5. File saved as an Adobe .pdf document.
- 6. Grammar and spelling count.
- 7. The papers must be turned in on Canvas by midnight on the due date.
