#### **Course Description**

Students learn how to build data visualizations that provide insight into the nature of the relationships of interest within the data, as well as how to build visualizations to effectively convey the insights they discover, using contemporary tools. These techniques will enable them to create knowledge that empowers data-based decision making. Visualizations will use data drawn from business operations and business-relevant societal contexts and include temporal and geospatial data.

In many ways, it can be useful to think of this course as a data-visualization-centric communication class which leverages business, data, design, and communication concepts at their intersection.

Note: Some course content or students' interventions may be deemed offensive by you or other students. Please, bring this to my attention in a respectful and well supported manner, so I can take appropriate measures.

#### **Course Learning Outcomes**

Upon completing this course, the student should be able to:

- Identify when and what visual communication is appropriate to convey a message
- Identify enhancer and obstructer elements of good visualizations
- Recognize the fundamental characteristics of data for visual analysis
- Recognize different techniques for visually exploring and explaining data-based observations
- Use data visualizations to facilitate and enable decision making
- Build effective data visualizations in Excel and Tableau

## **Course Objectives**

The Undergraduate Program of the W.P. Carey School of Business has established the following learning goals for its graduates:

- 1. Critical Thinking
- 2. Communication
- 3. Discipline Specific Knowledge
- 4. Ethical Awareness and Reasoning
- 5. Global Awareness

All of the items in bold have significant coverage in this course. Critical thinking will be built around how we identify goals and the choices of how we consider and convey the data to accomplish them. Communication will center around how we convey results to ourselves through exploratory activities and to others through explanatory activities. The knowledge of techniques we acquire is custom to the computer information systems discipline. We will make ethical choices in how we choose to consider and present our analysis as we endeavor to create visuals that are both compelling and responsible. Finally, our data sources and consequently the questions we consider will draw from an awareness of our global society.

#### **Deliverables**

The following five categories of deliverables are used to determine your performance in this class. These deliverables are discussed in detail in the Deliverables Guide area of the course Canvas site.

- 1. **Assignments**: Assignments include the creation of graphics/diagrams and responding to methodological and conceptual questions covering assigned lectures for the current module as well as material from prior lectures and assignments.
- 2. **Application Tests**: In hands-on Application Tests, you build visualizations like those learned up to that point and answer questions that test your correct interpretation of those visualizations.
- 3. **Knowledge Quizzes**: Time-limited quizzes are mostly based on the textbook.
- 4. **Reflective Questions**: You participate individually and as part of groups in discussions that foster critical thinking and awareness of the wide diversity of issues affecting and being affected by data visualizations. The ability to effectively work in groups in an online environment is fostered, tested, and rewarded.
- 5. **Bonus for Involvement**: This deliverable is optional for students who want or need to compensate for eventual mishaps. These points are earned by asking or answering good questions and actively sharing useful information with the class.

Deliverables require students to apply the knowledge of the material they are currently studying. Students must do their own work to ensure mastery of the course materials. Unless explicitly stated otherwise, all assignments must be created digitally, using the appropriate software application, and **submitted on our Canvas learning platform by 11:59 pm on the due date**. This means that seeing 11:59 pm as the submission time likely translates into a late submission because the seconds that follow are not shown. **Only at 11:58 pm or earlier you can be sure the submission is on time**.

Please note that while sometimes you can submit an unlimited number of times, **only your final** submission will be evaluated.

Each student is expected to submit his/her own assignment. Do not give your assignment to another student to submit it. This will result in a ZERO for both students involved as well as academic dishonesty charges.

**Do not post solutions to any assignment on Discussion boards**. Doing so will be considered a violation of the university's academic integrity policy and will merit the appropriate consequences.

#### **Grading Policies**

All assignments will be graded based on, but not limited to, the following:

1. Completeness: Degree of completion of all assigned work

- 2. **Correctness:** The accuracy of the submission according to instructions, proper documentation, and format
- 3. **Grammar and Spelling:** Although right grammar and spelling won't give you points, wrong grammar and spelling will cost you points, so set yourself to the highest level of professionalism when producing your deliverables

Please note that your professor **does not round nor curve grades.** The score you earn is the score you receive.

To be fair to everyone, a student must submit all assigned course work on time as denoted on the course schedule, for it to be accepted. **Assignments will not be accepted late.** This policy will be strictly enforced.

This course is structured to reinforce personal responsibility. As such, for the most part, grades in the course are under your control.

Y grade options to replace satisfactory grades will only be used in very rare circumstances after consultation with the instructor before attempting the last test. Any requests must be made and resolved prior to the course's final assessment. Once a request is granted it is irreversible.

## **Grade Appeals**

Grades may be appealed within 24 hours of grades being posted for their assignment. Your professor and/or TA(s) will not notify you of these postings. It is your responsibility to regularly monitor your grades.

For all grade appeals please write a short memo outlining why you believe your grade should be reevaluated. Your case will be strengthened by responding to comments given in graded assignments, incorporating them into your response. If your appeal for reconsideration merits a further examination, I will be happy to do so.

Please be advised: I am often too generous rather than too stingy. As such, it is possible that when I reevaluate your work the grade you received may be lowered.

Before responding to any email related to these items, I will check our discussions board first, and refer you there if you have not already posted your question.

I will answer all requests in a timely fashion, generally the next working day. If you have waited more than 24 hours for a reply, please feel free to re-send or contact me via an alternative medium (Email or Canvas) to be sure I received the original request.

Always use your asu.edu email address when communicating with me. I may not even read emails from other email accounts.
