Course Description: This course examines legal theories, ethical issues, and regulatory climate affecting business policies and decisions.

Objectives

The course will help the future manager better understand business law and ethics.

Class Structure

Assignment Submission

Assignments are stored and submitted in Canvas. Do not email assignments to the professor. All written assignments (except Talking Points) will adhere to the following minimum APA 7th Edition formatting requirements and be submitted to Canvas as *Word* documents. PDFs, Pages, or Google Docs are not acceptable. Talking points must be APA 7th edition formatted as bullets. See your 7th Edition manual for specifics.

- Double-spaced (do not triple or quadruple space between sections).
- 12-point font in Times New Roman, 11-point font in Georgia, Calibri, or Arial
- One-inch margins all around.
- Indent every paragraph
- Align text to the left
- Insert the page number in the header, flush right.
- Write in the third person, present tense.
- Correct spelling and grammar are required. Students should run their papers through Grammarly.com to double-check spelling and grammar.
- Topic and subtopic section headings aligned to the rubric elements are required (<u>sample</u>).
- A title page with the student name, course name, section number, the paper's title, and submission date is required.
- A reference list page of works cited (embedded) throughout the paper.

Late Assignments

Assignments will be unavailable in Canvas after the due date.

Unless prior arrangements have been made, mid-term and final assignments not turned in on time will receive half points if submitted within 24 hours of the deadline. The exception to this rule is for final presentations. If the student is absent from the presentation, the student forfeits those points because the presentation cannot be delivered "late."

No credit will be given for assignments that are over 48 hours late. Due dates will be provided on the course schedule and assignments calendar. Second-chance opportunities to submit late work are available on a limited basis. Submitting late work as a regular practice is discouraged.

Attendance

Each student is allowed four (4) absences during the semester. Absences may negatively impact your grade. Additional absences without permission of the instructor will result in either a reduction in the student's final grade or involuntary withdrawal from the course. Students are responsible for assignments and readings even if they are absent. See Late Assignments above for submission guidelines.

Accommodations for Disaster, Military, Religious, and University Activities

Workload Expectations

The Arizona Board of Regents has a policy for how much time students should invest in their courses: "A minimum of 45 hours of work by each student is required for each unit of credit." Therefore, in a 3-credit course, students should expect to invest 45 hours in class meetings (or the online equivalent) and 90 hours doing homework and assignments for 135 hours in any given session (A, B, or C). This translates to 9 hours per week for classes that meet over a 15-week semester. For 7.5-week classes, the workload doubles to 18 hours per week, engaging in online

activities, reading, doing other homework, completing assignments or assessments, and studying. As you register for courses, keep this 135-hour standard in mind because, during some semesters, your work and/or family commitments may prevent you from taking full classes.

Participation and Collaboration

Students are expected to participate actively in course discussions. Assignments that have a participation component include points for participation. Students who do not participate will not receive full points for the subject assignment.

Students are expected to collaborate with other students to enhance their learning actively. Assignments may be identified as group or individual.

Appropriate Materials

Students are responsible for choosing materials for all projects and assignments. Inappropriate communication and materials that a reasonable person would find offensive are not permitted. A student who purposely presents and/or communicates offensive materials may withdraw academically from the course and face additional actions.

Electronic Review of Written Submissions

Written submissions will be submitted to SafeAssign, Turnitin, or a similar plagiarism detection program to ensure compliance with academic integrity policies. Submission of any writing assignment in the course to the professor constitutes consent by the student for the instructor to upload the paper to check against any anti-plagiarism database.

Syllabus Changes

Mindful planning has gone into the design of this course. However, if the instructor needs to change(s) to the syllabus during the term, students will be notified in class. Changes to the course schedule will be highlighted on the related Google document.

Plagiarism Statement

Student Conduct
