## **Learning Objectives**

- -Students will be able to talk in complete and correct phrases and sentences.
- -Students will be able to write complete sentences and paragraphs in a comprehensible way.
- -Students will read and understand basic texts.
- -Students will understand authentic documents and be able to discuss them.
- -Students will be able to narrate and communicate personal experiences.
- -Students will be able to conduct brief conversations on everyday topics.

# **Learning Outcomes**

In accordance with the American Council on the Teaching of Foreign Languages' (ACTFL)

Proficiency Guidelines, Spanish 102 seeks to increase students' Spanish-speaking ability to an novice-mid range to novice-high range proficiency level via the Course Objectives outlined below.

People with elementary level proficiency are able to handle successfully a variety of uncomplicated communicative tasks in straightforward social situations. Conversation is generally limited to those predictable and concrete exchanges necessary for survival in the target culture. These include

personal information related to self, family, home, daily activities, interests and personal preferences, as well as physical and social needs, such as food, shopping, travel, and lodging. Elementary speakers are able to express personal meaning by creating with the language, in part by combining known elements and conversational input to produce responses typically consisting of sentences and strings of sentences.

#### Tarea

Students may turn in assignments late but a 10% penalty will be assessed for every 24 hours the assignment is late. No exceptions! Please plan accordingly. Failure to provide accurate and appropriate documentation of an emergency in a timely manner will result in a grade of 0. It is the student's responsibility to notify the instructor through email if an assignment was handed in late and is ready for feedback. #### **Pruebas**

You will have 6 tests over material covered. Your lowest test score will be dropped. NOTE: There are NO MAKE-UPS. You have 90 minutes to answer each test. If you want to make full use of your time you need to begin at least 90 minutes before the deadline as the test will close automatically at 11:59pm even if your 90 minutes have not passed.

## **Vlogs**

The class will engage in module discussions on a variety of topics. Students will post 6 video blogs on everyday and personal interests within module framework. These video blogs or vlogs are meant to provide an informal and flexible space for you to practice your target language. Please be mindful of the deadlines as these cannot be made up. Vlogs CANNOT be uploaded to Canvas. Students must recorded directly to Canvas or upload a link.

## **Proyecto Final**

The final vlog is a community project where the student chooses a topic of interest to further elaborate. The final vlog is a place to demonstrate command of your target language. It will be due the final week of class and like Module Vlogs it CANNOT be uploaded to Canvas. Students must recorded directly to Canvas or upload a link.

#### **Examen Final**

The course requires a comprehensive exam which takes place at the end of the session.

  to delete materials on the grounds of suspected copyright infringement.

## **Sanctions**
