## Course Information

### Catalog Description

Introduces technological, social, and cultural principles and innovations for cities under the notion of sustainability and sustainable development within the global, regional, and local contexts.

### Course Description

This undergraduate course introduces the role of cities as they relate to global to local sustainability concepts and challenges. The course provides an urban perspective on environmental, socio-economic, and infrastructural sustainability problems and their consequences on natural systems and built communities.

Cities have a major role to play in achieving global sustainability as well as equal opportunity and fairness for its population. The course presents cities as complex and interconnected organisms that impact natural and socio-economic systems alike across temporal and spatial scales. By taking this course, students gain a better understanding of how cities can be a culprit, but also a major part of the solution to today's sustainability challenges. Students take an active role in assessing the sustainability of cities, identifying shortcomings or future needs, and communicating potential solutions.

## Course Delivery and Access

This is a hybrid course. This means that both in-person and online components are being incorporated. On Mondays, lectures will be **in-person starting at 1:30 pm to 2:45pm at Poly AGBC 112**. The second weekly lecture will usually be found online on the Canvas site. All in-class lectures on Mondays require attendance. All lectures, in person and online, are mandatory. Examinations will contain questions from both in person and online lectures as well as from documentary films.

Mondays will be primarily for live lectures but may also be used for Q&A sessions on readings and lectures, study sessions for exams, and assignment feedback/questions. Questions can be taken after class, as well: feel free to stay in the classroom after class and ask the instructor questions.

Online lectures are pre-recorded video lectures. Once online lecture videos are made available on Canvas student can access the videos at any time. Students do not need to access online lectures at specific days or times. Attendance for online lectures will not be taken, but all lecture content and assigned textbook readings will be part of the Mid-term and Final Exam.

# Assessment Activities

## Exams (15%)

There will be a midterm and final exam in this course. Both exams are online and will consist of multiple-choice and true/false questions and a study guide will be provided about 10 days prior. The exam is based entirely on the readings and lectures. The exams will not be on the content of the assignments, although the information in the assignments will help you to put the concepts into context. You are encouraged to take notes during every lecture.

## Attendance (15% total)

## Yellowdig Discussions (15% total)

In these discussions, you will respond to one or more of the course resources and discuss your personal interpretation and understanding.

## City Group Discussions (25% total)

In these discussions, your group will research and discuss specific aspects of your assigned city and how the module's topics and concepts might apply there.

*Note: All deliverables will be individually graded - there are no graded group projects. You will be evaluated on your participation and contributions to the group discussions.*

## Outline for the Envisioning the Sustainable City Paper (5% total)

For the 'Envision the Sustainable City - Full Paper you will need to submit an outline earlier.

## Full Papers (30% total)

Throughout the course you will be required to submit two larger papers. The first individual paper is the 'Researching Urban Sustainability Solutions' paper . The second individual paper is the Envision the Sustainable City - Full Paper.

## Submitting Assignments

All time frames used in class follow Arizona Mountain Standard Time (MST). Arizona does not observe daylight saving time (DST) from March through November; therefore, the time in Arizona will not align with other places that are on MST for half the year.
