### OVERALL PROGRAM GOALS

Construction management professionals combine knowledge of innovative technologies, construction principles and business management to lead a wide variety of construction projects from residential and commercial buildings to infrastructure projects. The DEWSC program goals are to teach students how to become responsible leaders in the construction industry through organization, leadership, and current/innovative management techniques. The American Council for Construction Education (ACCE) states that it is essential that every Constructor be capable of effectively managing personnel, materials, equipment, costs, and time. The Constructor must be able to effectively communicate and understand their role as a member of a multi-disciplinary team, the assessment of project risk, and the alternate methods that can be used to structure the owner-designer-constructor team.

### COURSE DESCRIPTION

This course analyzes the cultural context of construction, emphasizing its centrality in the evolution and expansion of the built environments as expressions of ethical and aesthetic value systems.

The purpose of this course is to broaden the student's awareness of the significance of construction as a discipline that affects, and is affected by, ethical and aesthetic values in all societies. It emphasizes the critical role that construction has played in the evolution of cultures and looks at the centrality of construction of today's rapidly changing world. The basis for forming sound judgments and developing wise philosophies in the diverse areas of the construction process will be illustrated. Specifically, the course will be devoted to a historical review of construction and a study of current global issues. Primary focus throughout the course will be on the human elements and issues that have impacted the industry and society.

### ENROLLMENT REQUIREMENTS

This course is open to all students at ASU, regardless of credits earned thus far, class standing, or major. In fact, one of the best parts of this class is the diversity of students, in terms of class standing and major, that it attracts.

### COURSE OBJECTIVES

In this course, students will:

- Gain an understanding of historical and current construction materials and methods.
- Compare and contrast pre- and post-Industrial revolution construction projects.
- Research historic construction projects.
- Research present-day construction projects.
- Analyze how the construction industry, and the people that it comprises, are discussed (or not) in the media.
- Explore how decisions are made, and have been made, about what to build and where to build it.
- Gain an understanding of the impacts of construction projects within the communities that they serve.

### EXPECTED LEARNING OUTCOMES

Students:

- **Understand** construction management and the construction industry. The roles and responsibilities of each team member. What it takes to start and complete a construction project.
- **Appreciate** the organization of a construction project, the team, the delivery method as it pertains to the management of construction documents and schedule
- **Identify** the role of the builder and estimating the cost of a project.
- **Summarize** how construction contracts, Prime & Subcontracts, impact how construction changes and distribution of financial risk.

## GRADING POLICY

The total number of points accumulated over the entire semester will determine grade. Reference the **Grading Matrix** (Canvas - Syllabus Tab) for a breakdown of points available and quantity needed for each grade level.

The Grading system is set up to reward engagement & participation throughout the entire semester. Points are what count - not Canvas algorithms.

- **Core Curriculum Points** include; In-Class Activities (ICA), Homework Activities (HA), Group and Individual Projects and Assessments.
- **Participation & Engagement Points** tally the number of on-time submissions for each CC type over the duration of the semester. (These points are added at the end of the semester but can be tracked with the P&E Rubric)
  - o **Core Curriculum + Participation & Engagement Points** equals the number of points to obtain an A. (Submit all CC activities on time and obtain a perfect score and your final grade will be an A.)
- **Extra Credit Points** can be used to supplement less than perfect CC efforts or late submissions.
  - o Extra Credit Activities are not required to mathematically obtain a final grade of A, however some ExC activities must be completed to receive an A+

## ASSIGNMENTS & COURSE ITINERARY

The responsibility for learning rests with each student. The instructor will assist by making the learning environment one conducive to various learning styles, but your preparation is essential. The student is responsible for completing all reading assignments and assigned homework problems, and seeking assistance if needed. Students are expected to bring relevant texts, required notes and handouts, appropriate writing materials, and a willingness to engage to every meeting with their classmates and instructor.

### ASSIGNMENTS:

To receive **Participation and Engagement Points** assignments and activities must be complete and submitted no later than the time/date posted on canvas.
