Course Objectives:

<u>Through examinations and assignments, upon completion of this course, students should be able to:</u>

- Identify and apply the appropriate equations to quantify work, power, and energy expenditure.
- Understand how enzymes facilitate reactions in the three energy systems to regenerate ATP.
- Comprehend the actions of the neuromuscular system in the process of muscle contraction and relaxation.
- Explain how hormones regulate physiologic function during exercise.
- Quantify oxygen uptake and measures of cardiopulmonary function.



- Demonstrate the physiological mechanisms underlying acute responses and chronic adaptations to anaerobic and aerobic exercise.
- Evaluate and interpret research findings.

This course is designed to address the physiological mechanisms of acute responses and chronic adaptations to exercise.

exams), but you are allowed two (2) attempts to ensure that you have learned the material. Once the due date and time for the syllabus quiz has passed, it **will NOT** be reactivated. Lecture Activities (LA's)

Exams will cover the content presented in lectures indicated in the exam schedule below. Each exam will consist of a combination of multiple choice and true/false questions. There will be one comprehensive final at the end of the semester on the date indicated in the schedule. There are NO make-ups allowed for any of these exams. If an emergency arises, notification PRIOR to the exam must be given to the instructor. All exams will be proctored in class with paper with answers recorded and graded on scantron.

Exam Study Guides (Optional)

Exam study guides will be provided for each of the 9 chapters that we will cover in this course. These study guides are meant to help you prepare for the exams but they are not worth a portion of your grade (i.e., they are optional). It is important to note that just because a content area may not appear on the study guide does not mean a question won't be asked about it on the exam. All lecture material is fair game for the exam. The study guides are simply a study tool that you can use if you choose. I will not review a study guide for correctness, however, you are always welcome to attend office hours to clarify any questions you have.

Active Reading
