Experience Summary - Biography

Mr. Weaver is currently a faculty member in the position of Senior Lecturer at Arizona State University teaching mainly in the fields of Concrete, Construction Contracts, Construction Safety, and Project Management in the School of Sustainable Engineering and the Built Environment (SEBE). Mr. Weaver is responsible for the Construction Safety course that is a requirement in the Construction Management degree program at DEWSC as a prerequisite for student internships. Additionally, Mr. Weaver teaches a senior/graduate level *Civil Engineering Project Management*

course, an elective in the Civil Engineering curriculum that attracts approximately 60 students per offering. Every other year, Mr. Weaver also teaches a senior level *Temporary Structures* course for Construction Management and Construction Engineering students as an elective offered to all seniors in the School of Sustainable Engineering and the Built Environment. Apart from faculty duties within the Department, Mr. Weaver works with the construction industry providing technical services as well as training and educational opportunities to contractors, engineers, and architects in the areas of construction contracts and specifications, claims and dispute resolution, safety, engineering design, and technical support related to concrete construction.

Mr. Weaver has consulted with project owners and engineering firms in contract development and interpretation, dispute avoidance and resolution techniques, as well as contract administration and construction inspection services. Mr. Weaver currently assists the Arizona Chapter of the American Concrete Institute as a PE Examiner for Concrete Field Technician Grade I, Concrete Strength Testing, Aggregate Testing, Flatwork Technician, and Level 2 Concrete Laboratory certification programs. Through the National Ready Mixed Concrete Association (NRMCA), Mr. Weaver is a certified Concrete Batch Plant Inspector, a Ready Mixed Concrete Batch Plant Manager, and a NRMCA Fleet Manager and has passed the Level 4 Concrete Technologist exam related specifically to concrete durability.

Mr. Weaver's background includes owning and managing his own residential construction firm and working as a project manager and estimator for a commercial general contractor. Prior to joining the North Carolina State University faculty in 2000, Mr. Weaver was the acting Director of North Carolina Construction Services for HNTB Corporation, a large A/E firm based in Kansas City, Missouri. As HNTB's North Carolina Construction Services Director, Mr. Weaver was responsible for contract negotiation and administration as well as managing a field staff of over 25 employees working as inspectors and technicians on large airport and bridge construction projects across the state. In his role as Project Manager with HNTB, Mr. Weaver worked on planning, design, and construction contract administration on projects at Raleigh-Durham International Airport, Brownsville (TX) International Airport, Charleston (SC) International Airport, and Dulles International Airport in Reston, Virginia, as well several regional airports within North Carolina. He also performed project constuctability reviews and was intermittently involved in analysis of construction claims in association with the HNTB National Claims Analysis group based in Prince William County, VA. The vast experience with airport construction led Mr. Weaver to occasionally work as a Friend of the American Concrete Paving Association (ACPA) Airports Committee in reviewing proposed Federal Aviation Administration specifications.

For seven years at North Carolina State University, Mr. Weaver taught a senior undergraduate and a graduate level 'Legal Aspects of Contracting' credit course, the Senior Construction Design Project Capstone course for Construction Engineering and Management, as well as administering and/or conducting one-day short courses for engineering professionals to meet Continuing Professional Competency (CPC) requirements mandated by the State of North Carolina. Mr. Weaver converted the graduate legal course to the Distance Education format making it available to students all over the country and abroad. This course was one of the most popular courses available to students desiring to obtain their Master's Degree in Civil or Construction Engineering through the Distance method as over 60 students enrolled and successfully completed the course over a three year period. As Senior Construction Extension Specialist, Mr. Weaver presented Construction Safety courses including 10 & 30-HR OSHA Training plus many individual Competent Person Workshops in the areas of Fall Protection, Confined Space / Control of Hazardous Energy, Bracing of Masonry Walls under Construction, and Trenching and Excavation for private concerns and organizations such as the Associated General Contractors of America (AGCA).

Working with the American Society of Civil Engineers (ASCE), Mr. Weaver assisted the National Council of Examiners for Engineering and Surveying (NCEES) in preparing the Architectural Engineering and Construction Engineering exams by coming together with other professional engineers from across the country to write examination questions. In 2012, Mr. Weaver worked on the NCEES PAKS committee reviewing the Civil Professional Engineering Exam content and now serves as a Construction Exam Committee member. Additionally, Mr. Weaver assisted the Mason Contractors Association of America (MCAA) by reviewing and revising the working manual 'Standard Practice for Bracing Masonry Walls under Construction' and reviewing and editing multiple chapters of 'Construction Contracts', a text written by Dr. Jimmie Hinze of the University of Florida. Mr. Weaver used Dr. Hinze's text for several years in his Construction Contracts course at North Carolina State University.

While working at North Carolina State University, Mr. Weaver was a member of the North Carolina Code Officials Qualification Board (NCCOQB) where he endorsed the certification of many outstanding State construction inspector candidates and was involved by duty in numerous hearings related to actions brought by the State against individuals employed by municipal and county inspection jurisdictions for dereliction of duty. As chair of the Qualification and Evaluation Committee to the Board, Mr. Weaver was responsible for overseeing the development of qualifications for certification as an inspector and also the evaluation system used for certification of municipal and county construction inspectors across North Carolina.
